<i>Persons could be injured if machine is unstable in high winds.</i>	<i>Yes</i>	<i>Stop if wind speed increases or wind causes platform to move. Do not carry items which increase wind loading.</i>	<i>Yes</i>
<i>Persons could be injured if machine is unstable due to being used on soft or sloping ground.</i>	<i>Yes</i>	<i>Only use machine if confident ground is both firm and level.</i>	<i>Yes</i>
<i>Persons could be injured if machine unstable due to overloading.</i>	<i>Yes</i>	<i>Do not operate machine above safe working load.</i>	<i>Yes</i>
<i>Persons could be electrocuted if the machine operates within 3 metres of overhead power cables. (8 metres from transmission lines)</i>	<i>Yes</i>	<i>Instruct the operator to cease all operations until all necessary precautions to make safe all electrical cables and or other services prior to operation.</i>	<i>Yes</i>
<i>Persons could be injured if machine contacts anything during operation.</i>	<i>Yes</i>	<i>Ensure adequate barriers are used to keep traffic away. Always check below before lowering/slewing. The operator should familiarise himself with overhead installations before use.</i>	<i>Yes</i>
<i>Persons could be injured if a safety harness is not worn on machine platform.</i>	<i>Yes</i>	<i>Ensure safety harness is worn at all times, and secured to the machine. Stand only on the floor of the platform.</i>	<i>Yes</i>
<i>Persons could be injured if they enter the swing area of the machine.</i>	<i>Yes</i>	<i>Instruct all persons on site not to place themselves under any part of the machine or swing area of the machine nor to pass any barricade.</i>	<i>Yes</i>
<i>Persons could be injured if the machine operator is unfamiliar with typical unsafe conditions and hazards that could affect the safe operation of the unit.</i>	<i>Yes</i>	<i>The operator should be trained in determining unsafe conditions and hazards that are relative to the machine's safe operation.</i>	<i>Yes</i>
<i>Persons could be injured if the machine or the operator fouls overhead installations.</i>	<i>Yes</i>	<i>Instruct the operator to familiarise himself with overhead installations in the workplace.</i>	<i>Yes</i>
<i>Persons could be injured if the operator performs duties that are not his responsibility and beyond the scope of his technical capabilities.</i>	<i>Yes</i>	<i>The operator should be instructed not to carry out any work that is outside his normal duties and report any matters of concern to his supervisors.</i>	<i>Yes</i>
